LED Street Light Project For 2015 Kenny Robertson, Chief Electric Operator, would like approval from the Council to go out for bids on his LED street light project for 2015.

Alderman Randall Mann entered the meeting at 5:45 p.m.

Kenny Robertson, told council that the new light project will replace lamps on Bulldog Avenue from Eckard's east to 41st Street, 25th Street from Crestview to Oakland Avenue and East Miller Street from Dairy Queen to KFC/Taco Bell. The lights will be installed on 56 aluminum poles. The LED lights last for 20 years and cost less than half to operate.

Discussion Held Regarding Carports

Jacob Doll, Code Enforcement Officer, told Council that he checked other communities' policies on carports. Jacob reported that the majority of the cities require a ten foot setback as a fire safety measure. Some towns that do not have such restrictions require

homeowners to install a fire barrier between the carport and the house. After further discussion, the Council decided to table the carports at this time.

Jacob Doll, Code Enforcement Officer, received a bill from a customer for mowing the right-of-way this summer. The council did not approve the bill.

Administrator Janelle Hagler and Jacob Doll will be going to Midland GIS on Wednesday, December 17th, with the corrections for the official zoning map.

Mayor & Administrator Attended Library Board Meeting Mayor Patrick Miller and Administrator Janelle Hagler attended the Library Board meeting on Wednesday, December 10. The Friends of the Library were also there for a discussion on book sales.

Administrator Janelle Hagler reported that the Christmas in the Park and the Fire Department chili supper was a success.

Minor Incident in Gas Department

The Gas Department had a minor incident on Wednesday, December 10th, when coming to the end of coiled gas pipe on a reel, it slipped off and started rolling back up striking Toby Puffer on the leg and hit the side of Sheriff's vehicle. Toby only received a bruise and Sheriff's vehicle had about \$800.00 damaged. Police report and insurance claim was submitted.

CTL Auction

CTL is having an auction on Friday, December 19th. The city was interested in purchasing the dump truck. The proper procedures were discussed to be able to purchase items at the auction. Alderman Todd Williams told council that the single axle two ton dump truck is mechanical sound.

Purchase of an F150 Ford Pickup

The city bought an F150 Ford pickup from Uptown Motors for \$5,500.00. Jacob Doll is driving the vehicle at this time.

FEMA Kickoff Meeting Held FEMA representatives were in town on Friday, December 12th, for the kickoff meeting to show how the paperwork is to be filled out. FEMA has done a preliminary damage assessment of \$23,475.00. Administrator Janelle Hagler will be getting estimates for the repairs to submit to Council and FEMA in January.

Mike Breer is still in St. Luke's Hospital with pneumonia. Mike works at the Water Treatment Plant. George Hulet, Water/Sewer Superintendent, is helping out at the plant during the evenings and weekend shifts.

New Boiler Installed at WT Plant Fritzel Cooling and Heating has completed installing the new boiler at the Water Treatment Plant.

Furnace Quit at Community Center

The furnace has quit at the community center. The cost to repair the furnace is approximately \$1,900.00.

Christmas
Lighting Contest

The Bethany Chamber of Commerce is having a residential Christmas Lighting Contest. In the past the City has awarded winners of the contest \$100.00 for first place, \$60.00 for second place, and \$40.00 for third place that will be applied as a credit to their utility bill. Council agreed to continue the utility credit donation.

Administrator Janelle Hagler told Council that the state, federal and county offices will be closed on Friday, December 26. The Mayor suggested the city will be closed if all employees donate a gift to the Mayor Christmas Tree and a can of food to the Food Pantry.

MIRMA Inspection of Power Plant & Transformers

Patrick Bonnot of MIRMA was here on December 2nd to inspect the power plant and transformers.

MIRMA Inspection of City Departments

Jeff Arp from MIRMA was also in town for an unannounced inspection. Jeff visited the Parks and Recreation department. Jeff observed an employee installing Christmas lights on a structure without wearing fall protection equipment. MIRMA would recommend installing signage on all pieces of playground equipment and additional signage along the walking trail where visitors park.

Job Application Placed For Street Superintendent Position

The Street Superintendent job application ad was placed in the Pony Express and the Republican Clipper. There has been one person apply for the position and another one inquired about it.

Electrical Rates

Administrator Janelle Hagler told Council that the city has been selling electricity to its customers for less than what it has been paying its supplier. Administrator Janelle Hagler estimated that the city would have to raise its electrical rate from 11.5 cents per kilowatt to 13 cents. Mayor Patrick Miller and Administrator Janelle Hagler told Council that when the figures are completed a special meeting will be held.

Approve UCI Contract

UCI contract for the employee's drug screening is up for renewal. Council approved the contract.

Sewer Project Complete on 17th Terrace

Alderman Steve Miles commented that Rodriquez Contractor did a good job on the sewer project on 17th Terrace.
